- Belle Creek Charter School Update
- Friendship Park storm drainage/parking lot discussion
 - School District 27J staff presented the history and past use of Friendship Park as a detention pond. The intent of Friendship Park with the new CTE addition was to continue the use of Friendship Park as a detention pond. The existing area where the new CTE Center has been built was a secondary retention area that can no longer can be utilized. In starting the construction process of enlarging Friendship Park and making it deeper some unusual items were discovered. Testing was conducted, and materials were found, that are consistent with a landfill. These items need to be taken care of. 27J has partnered with a geotech firm and CDHPE to discuss the next steps. The items found are not at a level that requires communication of a public health hazard. Additional testing will need to take place, and additional steps will be discussed regarding the use of the site. It is believed that a new storm water system will need to be considered. A potential solution of a parking lot in the area of Friendship Park is also being discussed. Additional information will be shared with the Bond Oversight Committee in the future if additional funds are required.
